SIMSBURY COMMUNITY TELEVISION, INC. (hereinafter "SCTV"), and the person whose name appears above as producer or program provider (hereinafter "Producer/Provider"), hereby agree to the following terms and conditions related to the broadcasting of the program listed above.

1. Broadcast Time Slot. SCTV agrees to make available to the Producer/Provider a time slot in accordance with the SCTV Community Access Channel Policies & Procedures, a copy of which was received, read and understood by the Producer/Provider, so that the Producer/Provider's program can be broadcast by the Television Service Providers, including but not limited to Comcast and AT&T U-verse (herein after referred to as the "TV Service Providers") in Simsbury.

2. Limits of Liability. Producer/Provider agrees that neither SCTV nor the Television Service Providers shall have any liability for interruptions in broadcasting, or for any failure to broadcast the Producer/Provider's program due, but not limited to mistake, power failures, equipment failure or other reasons. Further, Producer/Provider agrees that in the event of a disruption SCTV's liability shall be limited to SCTV providing access to the community access channel or channels at another time.

3. Producer/Provider Liability. Producer/Provider shall make all appropriate arrangements with, and obtain all clearances and rights from broadcast stations, networks, sponsors, copyright holders, music licensing organizations, performers' representatives and any and all other persons or entities as may be necessary to broadcast the Producer/Provider's program material by TV Service Providers. If the Producer has used other works in the creation of a work and such copyrights, performance rights, and other rights needed for broadcasting the work used is owned by another person or entity, the Producer must obtain the permission from the holder(s) of said rights.

4. Producer/Provider to Indemnify. In recognition of the fact that neither SCTV nor the TV Service Providers will pre-screen the content of the Producer/Provider's program material for compliance with the terms of this agreement, the Producer/Provider hereby accepts full liability for his or her acts and omissions, and the acts and omissions of all users associated with his or her programming, and in so doing agrees to indemnify and hold harmless SCTV, the TV Service Providers, and their respective parents, subsidiaries, affiliates, directors, officers, employees, agents, representatives, successors and assigns, from any and all liability or damages (including reasonable attorney's fees) arising from or in connection with claims or causes of action for failure to comply with any applicable federal, state or local laws, rules or regulations or claims or causes of action for slander, libel, commercial disparagement or unfair trade practice, defamation of character, infringement of privacy or publicity rights, copyright, musical performing rights, unauthorized use of trademark, trade name or service mark or any other literary, dramatic or contractual right of any person, for breach of contractual or other obligations owing to third parties, or for any other injury or damage in law or equity, which claims result from said Producer's/Provider's programming being viewed over SCTV access channel(s), live streaming from www.simsburytv.org or other internet provider sites.

5. Prohibited Content. The Producer/Provider shall not produce or provide programming for broadcasting on the access channel(s) which contain the following:

- a. a lottery or any advertisement or information concerning a lottery or game of chance;
- b. any presentation of advertising material designed to promote the sale of commercial products or services (including advertising by or on behalf of candidates for public office);
- c. obscene material
- d. sexually explicit conduct; or
- e. material soliciting or promoting unlawful conduct.

6. Copyright and License. The copyright to the programming created by the Producer using SCTV equipment shall be owned by the Producer. However, the Producer licenses to SCTV, in perpetuity, the non-exclusive right to broadcast the programming over the SCTV access channel(s) live streaming to its website and posting to internet sites such as You Tube and similar providers, to make copies for non-commercial uses including, but not limited to maintaining a station archive of programming produced, exhibits, video contests, and individual copies where such copies are intended only for individual home viewing and not as part of any marketing plan for general duplication and distribution. The Producer further assigns to SCTV for a period of 20 years all of his/her rights to receive fees or royalties from copies or uses made from the programming unless the production fee and royalties, fees or other compensation as provided for in the following paragraph is paid.

7. Production Fee. Use of the access channel(s) or SCTV equipment or services for the monetary or financial gain of the Producer/Provider, any other individual or entity is strictly prohibited. If the Producer duplicates, displays, telecasts, or performs any programming created with SCTV equipment over any medium and receives compensation therefore, or if the work is broadcast over any commercial video distribution system, the Producer shall pay to SCTV a production fee, the amount of which shall be based on the prevailing fair market value, at commercial rates, of the production equipment and services provided by SCTV and used for the creation of the work.

8. Master File Ownership. If the work is recorded on digital equipment that is owned by SCTV, ownership of the digital master file remains with SCTV. Because SCTV deletes the master files it owns, SCTV may delete the Producer's work at any time without liability. If the Producer wishes to own the digital master file, it is the Producer's responsibility to arrange for preservation of his or her work by providing a means to receive the digital master file at its sole cost and expense.

9. Legal Requirements and Restrictions. The Producer/Provider further agrees to be bound by any access channel programming requirements or restrictions imposed on SCTV by local, state or federal law, including any rules, regulations, decisions and laws now in existence or subsequently enacted by the State of Connecticut and the United States of America, and by all existing and subsequently adopted policies, restrictions and rules of SCTV, itself, as access manager, that reasonably further its mission and the observance of said rules, regulations, decisions and laws.
